A BILL

To amend title XVIII of the Social Security Act to provide for the distribution of additional residency positions to help combat the opioid crisis.

- 1 Be it enacted by the Senate and House of Representa-
- 2 tives of the United States of America in Congress assembled,
- 3 SECTION 1. SHORT TITLE.
- 4 This Act may be cited as the "Opioid Workforce Act
- 5 of 2019".
- 6 SEC. 2. DISTRIBUTION OF ADDITIONAL RESIDENCY POSI-
- 7 TIONS TO HELP COMBAT OPIOID CRISIS.
- 8 (a) IN GENERAL.—Section 1886(h) of the Social Se-
