A BILL

To require reports on, and the coordination of trade policy with respect to, articles that may be needed to respond to the COVID–19 pandemic.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Strategic Global Sup-
5 ply Chains Act of 2020”.

1 **SEC. 2. REPORTS BY INTERNATIONAL TRADE COMMISSION**
2 **ON ARTICLES NEEDED TO RESPOND TO**
3 **COVID-19 PANDEMIC.**

4 (a) IN GENERAL.—Not later than 60 days after the
5 date of the enactment of this Act, and every 60 days there-
6 after, the United States International Trade Commission
7 shall submit to Congress and make available to the public
8 a report that identifies articles that may be needed to re-
9 spond to the coronavirus disease 2019 (commonly known
10 as “COVID-19”) pandemic.

11 (b) INFORMATION REQUIRED.—Each report required
12 by subsection (a) shall provide, with respect to each arti-
13 cle identified in the report, the following:

14 (1) The 10-digit statistical reporting number of
15 the Harmonized Tariff Schedule of the United
16 States under which the article is classifiable.

17 (2) A legal description of the article.

18 (3) The rate of duty applicable to the article
19 under the column 1 general rate of duty column of
20 that Schedule.

21 (4) Any special or additional duty imposed with
22 respect to the article.

23 (5) With respect to any duty described in para-
24 graph (4):

25 (A) The date on which that duty was im-
26 posed.

1 (B) The authority under which that duty
2 was imposed.

3 (C) Whether the duty has been suspended
4 and, if so, the date of the suspension and how
5 long the suspension is scheduled to last.

6 (6) The total rate of duty applicable to the arti-
7 cle, including any special or additional duty de-
8 scribed in paragraph (4).

9 (7) The major countries of origin for the arti-
10 cle.

11 (8) The import value of the article imported
12 from each country described in paragraph (7) for
13 the 2 calendar years preceding submission of the re-
14 port.

15 (c) **SEARCHABLE FORMAT.**—The Commission shall
16 provide each report required by subsection (a) to Con-
17 gress, and post each such report on a publicly accessible
18 internet website of the Commission, in a format that per-
19 mits the report to be sorted by the categories of informa-
20 tion required under subsection (b).

1 **SEC. 3. COORDINATION OF TRADE POLICY LIKELY TO AF-**
2 **FECT UNITED STATES SUPPLY OF ARTICLES**
3 **NEEDED TO RESPOND TO COVID-19 PAN-**
4 **DEMIC.**

5 In developing trade policy likely to affect the United
6 States domestic supply of any article identified by the
7 United States International Trade Commission in the
8 most recent report required by section 2, the United
9 States Trade Representative shall consult with the Sec-
10 retary of Health and Human Services, the Secretary of
11 Defense, and the Administrator of Federal Emergency
12 Management Agency.

13 **SEC. 4. TERMINATION.**

14 The requirements of sections 2 and 3 terminate on
15 December 31, 2022.
