## Region 1 totals

### Individual Assistance

#### **Lost Wages**

All six New England states received the maximum six weeks of lost wages Program grants totaling \$2,136,792,285

#### **Crisis Counseling**

Crisis Counseling approved for all New England States. Total amount obligated for Crisis Counseling is \$14,333.675.

- New England states have received \$2,872,139 for the Immediate Services Program
- New England states have received \$11,560.316 for the 9-month Regular Services Program

### Public Assistance

To reimburse local, state and tribal governments for the costs of emergency protective measures, FEMA provides financial relief in the form of PA grants. As of April 1, Public Assistance has completed the following:

- Approved 1,974 Request for Public Assistance
- Formulated 2,197 projects
- Awarded 890 projects for a total of \$1,010,232,421

### Resource Allocation

#### **Personal Protective Equipment**

As of April 1, FEMA Region I supplied PPE to New England states and Tribes totaling 25,942,216 pieces. This includes:

- 10,935,047 gloves
- 1,227,703 face shields
- 627,631 surgical gowns
- 2,632,408 surgical masks
- 10,518,377 N95 respirators
- 1050 ventilators

#### **Vendor Box Meals**

As of April 1, Region 1 distributed 1,843,893 vendor box meals to New England states and tribes.

### **Disaster Relief Fund**

New England states and tribes have received \$3,407,427,100 from the FEMA Disaster Relief Fund as of March 24.

### **Long Term Recovery**

- Long Term Recovery has completed the Rapid Needs Assessment for all six states and are beginning Mission Scoping Assessments to determine resource gaps and shortfalls.
- Long Term Recovery Interagency Recovery Coordination will help identify sources of Federal and non-federal funding for costs not covered by FEMA Public Assistance, where applicable.

### **Connecticut**

- **Disaster Relief Funds:** As of March 24, FEMA obligated \$466.1 million in federal support to Connecticut.
- **Personal Protective Equipment:** Connecticut has received the following amounts of PPE: 1,291,000 gloves, 188,446 face shields, 88,456 surgical gowns, 528,205 surgical masks, 6,350,035 N95 respirators and 350 ventilators as of April 1.
- **National Guard:** Connecticut has 629 National Guard troops activated under Title 32, as of March 31.
  - Title 32 approved until Sept. 30 with a 100% federal cost share.

### **Individual Assistance**

- **Crisis Counseling:** Providing for the people of Connecticut during these stressful times FEMA, in close coordination with the Substance Abuse and Mental Health Administration, provided \$704,038 through the Crisis Counseling Immediate Services Program (ISP) to help counsel those affected by all aspects of COVID-19.
  - On June 2, the state was awarded a 60-day grant to fund ISP.
  - Connecticut received a 30-day extension to its ISP grant to allow enough time to continue its crisis counseling program during the RSP application review process.
  - On Sept. 9, the RSP was approved in the amount of \$3,080,526.80

- **National Guard:** Maine has 102 National Guard troops activated under Title 32, as of March 31.
  - Title 32 approved until Sept. 30 with a 100% federal cost share.

- **Personal Protective Equipment:** Massachusetts has received the following amounts of PPE: 770,794 gloves, 220,105 face shields, 115,367 surgical gowns, 737,365 surgical masks, 1,643,074 N95 respirators masks, and 600 ventilators as of April 1.
- **National Guard:** Massachusetts has 246 National Guard troops activated under Title 32, as of March 31.
  - Title 32 approved until Sept. 30 with a 100% federal cost share.

## Individual Assistance

- **Crisis Counseling:** Providing for the people of Massachusetts during these stressful times FEMA, in close coordination with the Substance Abuse and Mental Health Administration, have provided \$707,507 through the Crisis Counseling Immediate Services Program (ISP) to help counsel those affected by all aspects of COVID-19.
  - Massachusetts awarded the 60-day ISP grant on April 18.
  - Since that time, Massachusetts introduced its new program, Mass Support, a free and anonymous statewide crisis counseling program, managed by Riverside Trauma Center and the Massachusetts Department of Mental Health

**Long Term Recovery: Sector-Based/Outcome Driven Recovery:**

- Critical needs are higher education, housing, childcare, fisheries and technology
  - The Economic Development Administration awarded \$662,922 CARES Act Recovery Assistance grant to Salem, Massachusetts to implement a recovery strategy plan for long-term recovery and ensure the region's tourist economy remains competitive. The grant will be matched with \$165,730 in local investment and is expected to create nearly 400 jobs.

**New Hampshire**

- **Disaster Relief Funds:** As of March 24, FEMA obligated \$235,027,400 in federal support to New Hampshire.
- **Personal Protective Equipment:** New Hampshire has received the following amounts of PPE: 2,751,639 gloves, 107,120 face shields, 41,162 surgical gowns, 227,249 surgical masks, and 511,973 N95 respirators as of April 1.
- **National Guard:** New Hampshire has 394 National Guard troops activated under Title 32, as of March 31.
  - Title 32 approved until Sept. 30 with a 100% federal cost share.

**Individual Assistance**

- **Crisis Counseling:** Providing for the people of New Hampshire during these stressful times FEMA, in close coordination with the Substance Abuse and Mental Health Administration, have provided \$120,924 through the Crisis Counseling Immediate Services Program (ISP) to help counsel those affected by all aspects of COVID-19.
