## Statements of Support for Senator Hassan's Bipartisan Recovery Startup Assistance Act

The Senate voted to advance comprehensive COVID-19 relief, which included the <u>bipartisan</u> <u>Recovery Startup Assistance Act that Senator Hassan introduced</u> to provide payroll assistance through the Employee Retention Tax Credit to new small businesses started during the pandemic. Judi Window, Owner of Diz's Cafe in Manchester: "Being life-long local NH residents who had aspirations of opening a small, owner run restaurant in 2020, turned out to be very different experience than our business plan envisioned in January 2020. We were on schedule and on budget to open April 1, 2020. But the joke was on us! The pandemic came in full-force in March closing down not only our city and state, but the entire world. Gritting our teeth, we persevered and opened our take out window on May 29th. Followed by opening our doors with strict Covid-19 guidelines. Thinking the summer or fall or winter would be better, it's now March 2021 and now worse. We need help. We need support. We need people. Without being an income producing company in 2019, it has limited our application for funds. Yes, we have received a little funding, but we need more to make it through this next push towards "normal" life. We thank Senator Hassan and all of our NH officials who have been working diligently on behalf of NH's small and new businesses."
